

News from the President

2017 was a very significant year for the Association given it was our fiftieth anniversary. Sadly we can tend to forget pioneers and their achievements in this time-poor era. However the work done by Stan Dean and his team in the late 1960s and early 1970s should be remembered as we walk around our wonderful streets. They saved South Parkville as we now know it from the clutches of inappropriate development.

Many people have tales of the Association and we must remember some residents were not happy at what they saw as too much control. We have now evolved into a group with community spirit at heart and recognise boundaries that the City Council accept and we can help manage.

The course set over the past couple of years has been cooperation with the City Council and its wonderful Engineering and Planning departments. Cooperation has been the focus and assisting residents in any way possible to make lives better.

Key achievements in 2017 were:

- Traffic calming continuing in Park Drive with the new roundabout at Morrah Street
- Smoothing of some bluestone laneways to enable mobility scooter to access
- Parking changes given the oncoming increase in Melbourne Metro workers in the area
- Representation on Melbourne Metro committees and liaison with Melbourne Metro protecting where possible the needs of members and residents. This was particularly important when original plans had Gatehouse Street as a key diversion for Grattan Street. Council supported us in maintaining current traffic management on Gatehouse Street.
- Relationship building with other key players in the Parkville area including the University Colleges
- Liaison with Council's Planning Department on development proposals in Parkville
- Successful 50th anniversary and Christmas community events
- Working on submissions on the Local Heritage Policy Review Amendment C258 to the Melbourne Planning Scheme
- Building key relationships with local members both Federal and State Parliament
- Being part of promoting the station name **Parkville**!!!!

A lot of what we achieve is to a certain extent taken for granted. However the next seven years of the Melbourne Metro project will be a test as we are in the midst of traffic changes. As an Association, we will use our seat at the table to aim that we are impacted adversely as little as possible.

Finally, the AGM is taking place shortly and we welcome residents that want to contribute to the area by joining the Committee. We have successfully built a team to move forward but will have a couple of vacancies for enthusiastic individuals. We meet monthly (other than December and January) and expect all Committee members to attend the majority of meetings.

City of Melbourne Waste and Resource Recovery Strategy 2030

The City of Melbourne is preparing a Waste and Resource Recovery Strategy 2030 that will include actions to improve recycling and reduce the amount of waste. Melanie Oke, Council's Waste Management Coordinator, attended the February Committee meeting and provided information on the Strategy's preparation and on-going waste management issues.

The Strategy will identify Council's vision, set reduction targets, and include a four year implementation plan. It will take account of waste generated by residents, businesses, construction and demolition activities, and through Council's own operations.

Council currently provides a wide range of waste services, yet knows that the city is growing and evolving. Your input will help Council not only keep these services relevant, but also to identify gaps and develop innovative ideas and programs.

Traffic and parking matters

Melbourne Metro - closure of Grattan Street

Residents should be aware by now that Grattan Street between the east side of Royal Parade and the west side of Leicester Street will close on 19 February for a period of up to five years to facilitate the construction of the Parkville Station by Melbourne Metro's contractors CYP. The Association will continue to liaise with Melbourne Metro and the Melbourne City Council in relation to any traffic and parking issues that may result in South Parkville.

The Association is represented by Rob Moore on the Metro Tunnel Community Reference Group: Parkville Precinct. The next meeting is to be held on Friday, 9 March – if you have any issues or questions about the Parkville station construction, please contact Rob on 0418 325 624.

Heritage and planning matters

Further submission on Amendment C258 Local Heritage Policy Review

The Association made a submission in January on the re-exhibited heritage inventory. The need for an updated heritage study of Parkville was reiterated to improve the evidence base that underpins the heritage inventory and assessment of whether individual buildings are 'significant' or 'contributory'.

Trinity College proposal, 29 – 35 Royal Parade (corner of Morrah Street)

A community information session was hosted by Trinity College on 6 February to enable residents to view draft plans for the proposed five level redevelopment (three above ground, two below ground) of the College's properties at 29 to 35 Royal Parade up to the corner of Morrah Street.

The session was only attended by a handful of residents but discussion ensued with the College and its architects and planners about issues including building bulk and design and integration with the heritage precinct. It is anticipated that an application for a planning permit will be lodged with Council in the next few weeks. The Association will review the lodged plans and, if there are planning policy issues arising, will lodge a submission.
