

# Minutes of the 56<sup>th</sup> ANNUAL GENERAL MEETING - 2023

MONDAY, 19 JUNE 2023 at 6:30pm – Naughton's Hotel

The meeting commenced at 7:00 pm

Robert Moore (President Parkville Association) welcomed members and guests. He introduced the Guest Speakers,

Director, Engagement and Partnerships - The University of Melbourne **Padmini Sebastian OAM** 

Padmini represents not only the University at its Parkville campus but also at campuses in Central Victoria (at Dookie) and in the Northern Territory. She explained that the University had some 10,000 staff spread over nine (9) separate campuses. Museums and Galleries were an integral part of the Universities activities and a direct interface with its communities. The University was directly involved with integrating indigenous peoples into its activities, especially in cultural aspects. It also co-operates with the City of Melbourne and has also reached out to the Carlton community groups. There was a direct role the Association could play in assisting to cater for the needs of the University's students within industry and housing sectors, Padmini opined.

The President moved a vote of thanks to Padmini for her attendance and address.

## Senior Open Space Planner - Melbourne City Council **Alicia Otto**

Alicia presented a summary of the development of the new Master Plan for Royal Park. An audit of various park activities is now completed and is available for consultation on the City of Melbourne "Participate Melbourne" website. There were 78 individual responses and 25 audits were conducted over a three-week period earlier in 2023. Eight key themes have been identified as Master Plan priorities. The Final Plan is due for release in June 2024.



Alicia revealed that University of Melbourne's Dr Anne Cummins has been commissioned to report on individual stakeholder interactions in the current period to 2030.

Neighbourhood Partner – Melbourne City Council **Nas Mohamud** 

Nas is the City of Melbourne's conduit for the community to the Melbourne City Council's community engagement project "Participate Melbourne". She advised the Association could assist in the Melbourne City Council- University of Melbourne joint initiative to assist students engaging with the community.

### 1. The President presented a summary of the Association's activities during the past year.

The Association has 180 members, including 57 Life Members. An apology was received from Association Treasurer Dave McGregor (ill with influenza). The President recognised Nelson Alexander's \$5,000 donation and the gift of producing four quarterly newsletters. He outlined his involvement in representing the Association in several groups: Community Reference Group within the City of Melbourne; The Police Community Consultative Committee (PCCC) Melbourne West Safety Group; The Quarterly meetings of the Presidents of Residents Group chaired by Lord Mayor Sally Capp and regular liaison with University of Melbourne (represented by Pamini Sebastion) and University High School through its Principal (add name).

#### 5 PRESIDENT'S REPORT Robert Moore

President Rob Moore summarised the activities of the Association for the past year. He commended the efforts of residents in raising money to assist funding the Association to fight the appeal by developer Parkville Properties Pty Ltd (Professor Rodney Sinclair, principal) at the Victorian Civil Appeals Tribunal [VCAT] to overturn the MCC decision not to grant a planning permit to construct a medical centre on land at 35-39 Royal Parade.

He especially thanked Ray Osborne in presenting a comprehensive heritage study of the existing building at the site. He also reported that eight days of hearing was conducted at VCAT but a decision is yet to be handed down.

The President reported the residents of Parkville had raised a total of \$65,000 and the Parkville Association had contributed \$24,000 (including a \$5,000 from Real Estate agent – Nelson Alexander) that funded the Association's appearance at the eight-day VCAT Hearing.
